BUSINESS MINUTES SEMINOLE CITY COUNCIL April 25, 2023

The Business Meeting of the Seminole City Council was held on Tuesday, April 25, 2023, at 6:00 p.m., in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

Mayor Waters called the meeting to order at 6:00 p.m.

Councilor Thom Barnhorn provided the invocation and led the Pledge of Allegiance.

- 2. All applications shall be submitted to the City Clerk instead of the Department Director,

CITY COUNCIL REPORTS

<u>Councilor Barnhorn</u> – Councilor Barnhorn attended the groundbreaking for Valor Preserve; participated in a conference call with the Florida League of Cities; attended a zoom meeting with the National League of Cities; attended a baby shower for the City's IT Specialist Eddie Mui; attended and read names for the Day of Remembrance at the Holocaust Museum; attended the Seminole Art in the Park; attended the American Legion 27th Annual Gong show; and participated in the honor flight ceremony at the St. Petersburg/Clearwater Airport.

Councilor Burke – Councilor Burke attended the groundbreaking for Valor Preserve.

<u>Vice Mayor Edelman</u> – Vice Mayor Edelman attended the groundbreaking for Valor Preserve, and participated in the Florida League of Cities Monday morning briefings.

<u>Mayor Waters</u> – Mayor Waters attended the groundbreaking for Valor Preserve; attended the Seminole Art in the Park; read names for the Day of Remembrance at the Holocaust Museum, and volunteered at the Interfaith Food Pantry.

5. <u>CITY MANAGER REPORT</u>

A. FORWARD PINELLAS REAPPORTIONMENT PLAN.

City Manager Toney-Deal deferred to Councilor Burke to explain the proposed reapportionment plan, as he serves on the Forward Pinellas Board. Councilor Burke stated that every ten years, Forward Pinellas reviews the reapportionment of the citizens of Pinellas County and of the representatives on the Forward Pinellas Board. Whit Blanton of Forward Pinellas and his staff completed the reapportionment analysis and presented it to the Forward Pinellas Board. The City of Dunedin contested it and it was re-evaluated and then once again presented to the Board for a vote with Dunedin changed from a dual seat to a single seat, and the Board approved it. Tarpon Springs contested said decision after the approved vote. It is now in a state of flux until it is decided which cities are teamed up and which cities get a single seat. It will be re-examined by Whit Blanton and staff and go before the Forward Pinellas Board for a vote in July.

B. <u>FLORIDA LEAGUE OF CITIES E. HARRIS DREW MUNICIPAL OFFICIAL LIFETIME</u> <u>ACHIEVEMENT AWARD.</u>

City Manager Toney-Deal announced that the applications are now available for the E. Harris Drew Municipal Lifetime Achievement Award. It requires two (2) elected officials to nominate another elected official.

C. <u>UPDATE ON PINELLAS COUNTY LIFT STATION ON PARK BOULEVARD, IN FRONT</u> OF HOME DEPOT.

City Manager Toney-Deal introduced Deputy Utilities Director of Pinellas County, Hillary Weber, and Engineering Section Manager, Tom Menke, of the Pinellas County Utilities Department to give a brief update about the Lift Station. Ms. Weber stated that a CIP project rebuild of the pump station is currently slated to be complete by 2027. Mr. Menke clarified that the odor issue will be rectified much sooner than that, Ms. Weber was just giving a long-term overview. The air odor control filtration system is out of order and should be rectified once a supply shipment is received.

Discussion ensued and Council expressed concern and disappointment over the completion date. Ms. Weber and Mr. Menke stated that with the new filtration system and more frequent monitoring, they are hopeful that it will resolve the issue.

Mayor Waters concluded the discussion by asking that Ms. Weber and Mr. Menke touch base with City Manager Toney-Deal in a couple of months to give her an update on this project.

City Manager Toney-Deal distributed the draft application for grants for non-profit organizations. She asked Council to review and approve so that it can be sent to the organizations that have already received grants this year, and to any others that have inquired, and it will also be posted on the City's website. At the budget workshop, Council will decide on the grant allocations.

City Manager Toney-Deal attended the Seminole Art in the Park and Friday's Chalk Walk. She thanked Dwayne and Kacy for their hard work during the events.

City Manager Toney-Deal gave a brief Legislative update.

6. OLD BUSINESS

Councilor Springer expressed concern about the Community Rating System Discount for flood insurance. She stated that it has an effect on discounts for flood insurance for City residents. She stated that Seminole does not currently participate in the program and she is asking the City Manager to review.

Motion made by Councilor Springer, seconded by Councilor Olliver to have the City Manager review on how to proceed for the City of Seminole to be included in the Community Rating System Discount.

ALL IN FAVOR. MOTION PASSED UNANIMNOUSLY.

Councilor Burke inquired about the fire inspection for the Clear Sky restaurant that a resident spoke about under public comment at an earlier Council meeting. City Manager Toney-Deal stated that the situation had been rectified and that it was a confusion on which permit was outstanding.

Councilor Burke had received an inquiry from a resident and wanted to know if recycling was an option through Waste Pro. City Manager Toney-Deal advised him that Waste Pro does provide recycling containers/services to residents as part of a single-family homeowners' waste collection fees.

Mayor Waters called a recess at 8:10 p.m. due to a health emergency. The meeting was reconvened at 8:24 p.m.
