I. Ordinance No. 08-2024: Z 2024-1: 9775 78th Avenue – Public Hearing (Quasi-Judicial).

City Attorney Daigneault explained the Quasi-Judicial hearing procedure and called to swear-in any individuals that would testify during the Public Hearing.

Community Development Director Wesley Wright stated that the applicants would like to rezone the property to allow for 2 ½ dwelling units, per acre of land, to construct an additional single-family home. The proposed zoning change complies with the City's Land Use map and would not negatively impact the future land use. The Development Review Board reviewed this request and forwarded a favorable recommendation to the City Council. Staff recommended the approval of Ordinance No. 08-2024.

City Attorney Daigneault offered for the applicants to make a presentation. The applicants waived making a presentation, but offered to answer any questions.

City Attorney Daigneault retroactively swore in Community Development Director Wright.

4. CITY MANAGER REPORT

A. Amendment to Payment of Sick Leave for Non-Bargaining Unit Employees.

City Manager Toney-Deal referenced City Council's previous approval of a 2%, per year of service, sick leave payout at time of retirement for bargaining unit employees. To stay consistent with bargaining unit employees benefits, City Manager Toney-Deal stated she is going to change the sick leave payout for all non-bargaining unit employees to 2%, per year of service or calculate in the manor now used, whichever is greater at the time of retirement. City Manager Toney-Deal brought this matter to the City Council for their consensus approval.

It was the consensus of the Council to support the Amendment of sick leave for non-bargaining employees.
