4. CITY MANAGER REPORT

A. Community Policing Report

City Manager Toney-Deal recognized Community Policing Officer Deputy Peter Papas. Deputy Papas reported on the upcoming Waterless Boat Parade and WinterFest, stating that the Pinellas County Sheriff's Department would have a boat, armored vehicle, and hummer

in the parade along with off duty officers and a team of officers patrolling on bikes. There will also be a team of Community Policing Officers working during WinterFest.

B. Save the Date for Community Events:

- Sail-A-Bration Holiday Waterless Boat Parade on December 8, 2024, step off at 6:00 p.m.
- Winterfest on December 13, 2024, from 5:30 p.m. 9:30 p.m. at the Recreation Center.

City Manager Toney-Deal recognized Recreation Director, Becky Gunter, to state the time for Council to arrive at the parade (5:20 p.m.) with roads closing at 5:30 p.m.

City Manager Toney-Deal stated that for the Winterfest tree lighting if Council Members would like to be on stage during the lighting they should report to the stage by 6:25 p.m.

City Manager Toney-Deal shared that Captain Mike Leiner, of the Pinellas County Sheriff's Office, would be retiring on January 10, 2025.

5. OLD BUSINESS

Vice Mayor Burke asked if the hurricane damage at the City's Emergency Operations Center (EOC) was repaired. City Manager Toney-Deal stated it was. Vice Mayor Burke also asked if the hurricane damage to Deputy Papas' police car was repaired or replaced. Deputy Papas stated his car was repaired by the Pinellas County Sheriff's Office.

6. NEW BUSINESS

Councilor Springer stated that the Florida League of Cities Legislative Action Days were coming up at the end of the week. Councilor Springer also shared that the Suncoast League of Cities had taken a hiatus due to its member communities being impacted by the hurricanes, but it would be resuming business in January 2025.

Mayor Waters invited the Councilors, Directors, and Deputies Papas and Siem to an ice cream social at Dairy Queen after the next Council meeting on December 17, 2024.
