

**BUSINESS MEETING MINUTES
SEMINOLE CITY COUNCIL
March 11, 2025**

The Business Meeting of the Seminole City Council was held on Tuesday, March 11, 2025, at 6:00 p.m., in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

Mayor Waters called the meeting to order at 6:00 p.m.

Councilor Al Shields provided the invocation and led the Pledge of Allegiance.

3. ACTION ITEMS

- A. City of Seminole Proclamation of Emergency for Hurricane Helene Extensions No. 25 & No. 26.

City Manager Toney-Deal stated that the Proclamation of Emergency for Hurricane Helene has once again been extended.

Motion made by Vice Mayor Burke, seconded by Councilor Shields to approve the seven (7) day extensions for the Proclamation of Emergency for Hurricane Helene, Extension No. 25 through March 25, 2025, and Extension No. 26 through April 1, 2025.

ALL IN FAVOR, MOTION PASSED UNANIMOUSLY.

- B. City of Seminole Proclamation of Emergency for Hurricane Milton Extensions No. 23 & No. 24.

City Manager Toney-Deal stated that the Proclamation of Emergency for Hurricane Milton has once again been extended.

Motion made by Vice Mayor Burke, seconded by Councilor Shields to approve the seven (7) day extensions for the Proclamation of Emergency for Hurricane Milton, Extension No. 23 through March 24, 2025, and Extension No. 24 through March 31, 2025.

ALL IN FAVOR, MOTION PASSED UNANIMOUSLY.

4. CITY MANAGER REPORT

- A. City of Seminole Strategic Plan Update.

City Manager Toney-Deal recognized Assistant City Manager/CFO Vince Tenaglia to give an update on the Strategic Plan. Mr. Tenaglia distributed a hand out and reviewed the four (4) pillars of the Strategic Plan.

- B. Community Policing Report

Community Policing Officer, Deputy Peter Papas, stated that he attended the Pow Wow festival and stated that all went well, with only one incident of a lost child. The child was quickly reunited with their parent.

- C. Reminder that the next City Council Meeting will be held on Thursday, March 27, 2025.

City Manager Toney-Deal reminded Council that the next scheduled Council Meeting will take place on Thursday, March 27, 2025. The change is due to the Florida League of Cities' 2025 Legislative Action Days.
