The Business Meeting of the Seminole City Council was held on Monday, September 22, 2025, at 6:00 p.m., in City Hall, City Council Chambers, 9199 - 113th Street North, Seminole, Florida.

Mayor Waters called the meeting to order at 6:00 p.m.

FISCAL YEAR 2025-2026 MILLAGE RATE AND GENERAL FUND BUDGET

A. Public Hearing, Second and Final Reading of Ordinance No. 06-2025: Establishing the Millage Rate for Fiscal Year 2026 (October 1, 2025 – September 30, 2026).

City Clerk Mancuso read Ordinance No. 06-2025 in its entirety. City Manager Toney-Deal stated that staff recommended a millage rate of 2.4793 mills, which is a 4.07% increase over the rollback rate of 2.3824 mills. This is the same tax rate that the city has had in place since fiscal year 2008.

C. <u>Law Enforcement Services Contract for Fiscal Year 2026 (October 1, 2025 – September 30, 2026) with the Pinellas County Sheriff's Office.</u>

City Manager Toney-Deal stated that she had a meeting with Sheriff Bob Gualtieri and he walked her through the budget. The Sheriff's Office is going through the same increases as the City, with insurance and personnel, etc. The Seminole Patrol assignments are not put out for bids, the Patrol Officers are assigned. The proposed contract also includes school crossing guards and our Community Policing Officer.

Motion made by Councilor Springer seconded by Councilor Beliveau to authorize the City Manager to execute the contract for Law Enforcement Services with the Pinellas County Sheriff's Office for FY 2026 in the amount of \$2,486,556.

D. City of Seminole Proclamation of Emergency for Hurricane Helene Extensions No.52, No. 53 and No. 54.

City Manager Toney-Deal stated that the city is undergoing City Hall repairs, including removing and replacing the new baseboards, repairing the City Council kitchen and bathroom area, and rebuilding the City Hall staff kitchen.

Motion made by Councilor Barnhorn seconded by Councilor Shields to approve the seven (7) days extensions for the Proclamation of Emergency for Hurricane Helene, Extension No. 52 through September 30, 2025, and Extension No. 53 through October 7, 2025, and Extension No. 54 through October 14, 2025.

E. <u>City of Seminole Proclamation of Emergency for Hurricane Milton Extensions No.50, No. 51 and No. 52.</u>

City Manager Toney-Deal stated that the city is undergoing City Hall repairs, including removing and replacing the new baseboards, repairing the City Council kitchen and bathroom area, and rebuilding the City Hall staff kitchen.

Motion made by Vice Mayor Burke seconded by Councilor Shields to approve the seven (7) days extensions for the Proclamation of Emergency for Hurricane Milton, Extension No. 50 through September 29, 2025, and Extension No. 51 through October 6, 2025, and Extension No. 52 through October 13, 2025.

4. CITY MANAGER REPORT

A. Music in the Park Concert Series, featuring the Whiskey Throttle Band, on September 26, 2025, from 7:00 p.m. through 9:00 p.m. at Seminole City Park.

City Manager Toney-Deal advised that Councilors need to report to the stage by 6:45 p.m. if they want to be introduced.

B. Gazebo Update.

City Manager Toney-Deal stated that the proposed area where the Gazebo will be installed at Waterfront Park has been staked out. She asked Councilors to stop by Waterfront Park to see if they agree with the size and area. This item will be placed on the next agenda for consideration.

C. City Manager Annual Evaluation.

City Manager Toney-Deal stated that all evaluations have been submitted. Once she has met with all Councilors, she will have the evaluations distributed to all of Council. She also distributed the City Manager's salary survey as requested by Council.

Motion made by Vice Mayor Burke, seconded by Councilor Quinn to authorize an increase to the City Manager's salary by 5%.

Mayor Waters called for Public Comment on the City Manager's salary increase. Receiving no requests for Public Comment on this subject, Mayor Waters closed the floor for Public Comment.

5. OLD BUSINESS

A. <u>Discussion on Non-Profit Organization Grant Distribution (FY 2025-2026 Allocation of \$30,000).</u>

Council reviewed the average proposed amounts as was submitted by each Council Member. The following amounts were agreed upon by concensus for each organization:

1. Vice Mayor Burke stated that the fishermen are once again blocking the travel lane on Park Boulevard at Lake Seminole. Vice Mayor Burke did notify Deputy Papas.

6. **NEW BUSINESS**

- 1. Mayor Waters announced that the Seminole Historical Society will be sponsoring is fish fry on October 5, 2025, from 5:00 p.m. to 7:00 p.m.
- 2. Mayor Waters announced that the Seminole Historical Society will be hosting speaker Dan Hirshberg, September 24, 2025.
- 3. Mayor Waters announced that the new "Open Carry" law takes effect in a few days, however, firearms are not allowed in Council Chambers during meetings.
- 4. Mayor Waters recognized Councilor Ray Beliveau for being nominated as Second Vice President of the Suncoast League of Cities. Councilor Beliveau will be sworn in on October 10, 2025, at Dunedin City Hall.
- 5. Vice Mayor Burke stated that based on Public Comment, he was wondering why there is standing water on Grove Terrace. Public Works Director Rodney Due addressed the issue, and stated that the standing water is not keeping the water from flowing.

City Manager Toney-Deal stated that the gate at Seminole Gardens has been permanently removed and in reference to public comment that she heard about the construction that took place on Grove Terrace, she wanted to clarify that it was Pinellas County, and not the City of Seminole. It was the consensus of Council to have the City Manager write a letter to the residents on Grove Terrace and Oakdale Terrace, and it was suggested that she forward what she had written to Council.

6. Vice Mayor Burke motioned, seconded by Councilor Shields to authorize the City Manager to investigate ways to reduce the Law Enforcement Budget.

Discussion ensued.

City Manager Toney-Deal asked for clarification on the motion. Vice Mayor Burke repeated the motion for the City Manager.
