ORDINANCE NO. 01-2023

AN ORDINANCE OF THE CITY OF SEMINOLE, PINELLAS COUNTY, FLORIDA; AMENDING THE OPERATING BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023, APPROPRIATING \$3,009,579 FROM FUND BALANCE FOR EXPENDITURES OF \$2,192,003 IN THE GENERAL FUND, \$126,544 IN THE MULTIMODAL IMPACT FEE FUND, \$166,313 IN THE GRANTS FUND, \$172,244 IN THE LOCAL INFRASTRUCTURE SALES TAX FUND, AND \$352,475 IN THE CIP FUND; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, revenues and expenses were originally adopted for Fiscal Year 2022-2023 through Ordinance No. 15-2022; and

WHEREAS, the authority for appropriation amendments is provided for in Article IX, Section 9.02 of the City Charter; and

WHEREAS, Florida Statute 166.241(5) provides for a municipality to amend its budget at any time during the fiscal year or within 60 days following the end of the fiscal year; and

WHEREAS, it is the desire of the City of Seminole to appropriate \$3,009,579 from fund balance for expenditure in the General Fund, Multimodal Impact Fee Fund, Grants Fund, Local Infrastructure Sales Tax Fund, and CIP Fund to the accounts listed below.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SEMINOLE, PINELLAS COUNTY, FLORIDA, DOES HEREBY ORDAIN:

SECTION 1. Appropriate \$3,009,579 in fund balance for expenditure as follows:
