

RESOLUTION NO. 05 -2018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEMINOLE, FLORIDA, VACATING A FIFTEEN FOOT (15') UNNAMED AND UNIMPROVED PLATTED RIGHT OF WAY, PINELLAS GROVES SUBDIVISION, LOCATED IN SECTION 26, TOWNSHIP 30 SOUTH, RANGE 15 EAST, PER PLAT BOOK 1, PAGE 55, PINELLAS COUNTY, FLORIDA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the property owner, Kathi Turner Schaeffer (Petitioner), has petitioned the City Council to vacate the following described property:

Lands described in the legal description attached hereto as Exhibit "A" and by this reference made a part hereof; and

WHEREAS, the Petitioner has shown that the vacation of the property described in Exhibit "A", will not affect the ownership of surrounding property owners; and

WHEREAS, the Petitioner's affidavit has been received by the City of Seminole; and

WHEREAS, the City of Seminole has no objection to the proposed right-of-way vacation, and that "Letters of No Objection" have been received from the utility and service providers, copies of which have been provided to the City; and

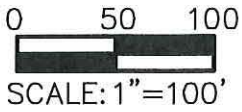

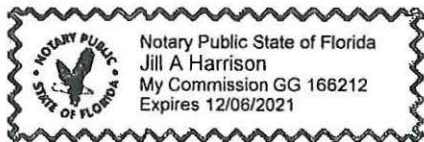

NOTICE IS HEREBY GIVEN that the City Council will hold a public hearing/public meeting at their scheduled meeting in the Seminole City Hall Chambers located at 9199 - 113th Street, Seminole, Florida, beginning at 6:00 PM, May 22, 2018.
